



Examples of questions that can be answered by 012 Immigration

- What is a letter of invitation? Who can process a letter of invitation? Who can authorise it?
- What are the requirements to enter Spain for a short stay?
- Do you always have to apply for an entry visa for short stays?
- When can you request an extension to your stay?
- Can you leave the country if your permit has expired but is being renewed?
- Where do you have to apply for authorisation to return?
- Can a foreign schoolchild whose situation has not been legalised leave the country on a school journey?
- How long can I spend outside Spain without losing resident status?
- In which cases can I extend my stay in Spain?
- If someone has an offer of a job in Spain, can he/she be denied a working visa?
- If I have a student card, can I work?
- What possibilities are there for me to qualify for legal residence in Spain from abroad? What if I'm already in Catalonia?
- What documents are required and where do I have to present them to apply for residence in special circumstances?
- What is the position of a minor whose parents' documentation is not in order? What happens if the parents' documentation has been regularised?
- How can I bring members of my family to Spain to live with me? What is the minimum income to claim the right to reuniting the family? Does an adult son or daughter qualify for family reuniting?
- How long is the report on the availability of domicile valid? Can I go directly to the notary to get the report on the availability of domicile?
- Can a son or daughter who has been reunited with the family work if he/she is old enough?
- When does a family member who has been reunited with the family qualify for residence independently?
- What documents are required and where do I have to present them for the first or second renewal of my card? What about a permanent permit? If I apply for a renewal and the administration has not answered, how is this interpreted?
- Can a foreigner's permit be renewed if he/she has been sentenced for a crime?
- Can you apply for a renewal if you are not working because of sickness?
- Can you work while your permit is being renewed?
- Can your permit be renewed if you are receiving RMI (income support)?
- How can I set up a business if I have a residence permit as an employee?
- How do I inform the administration of a change of address?
- While I have my first card what limitations are there on the sectors I can work in and where I can work? What changes can I apply for?

- How can I employ a foreign person who is not in this country? What happens if he/she is here but has no authorisation?
- What do I have to do to get a Spanish driving licence? Can I get a driving licence from my own country recognised?
- What are the requirements and procedures to become Spanish?
- What are the effects of an expulsion order?
- What do I need to do to marry a Spanish person? Or a foreign resident? A foreigner who has no residence permit? By attorney? Outside Spain?
- Under what conditions and according to what regulations can I stop living with someone or dissolve a marriage?
- What rights do the family members of EU citizens have? In which cases do you have to apply for an NIE (Foreigner's Identity Number)?
- If I am a citizen of one of the last ten countries to join the EU, what rights and freedoms do I have? Here? In my country?
- What is the legal status of a foreigner from a third country, related to an EU citizen, who wants to live in Spain?
- Is it possible to apply for a residence permit for a relative of an EU citizen, who is a citizen of a third country, and is in Spain without having regularised his/her situation?
- When does EU status cease to apply to a relative of an EU citizen?
- If the relative of an EU citizen loses this status, does he/she have to leave the country?
- Where can I renew my passport?
- What does a foreigner have to do if his/her residence card is lost or stolen? How do you apply for a duplicate of a favourable decision on an application for residence?
- What rights do I have without a residence permit? And if I am authorised to be here to study? And if I am a resident?
- Which foreigners are eligible for non-compulsory education?
- What are the requirements to receive grants, subsidies for books and dinners?
